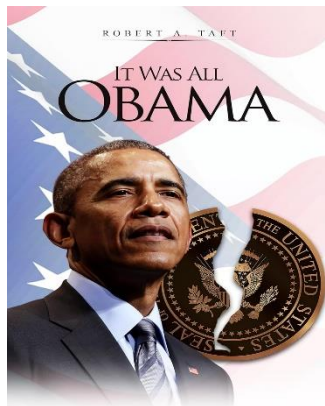

# **PART 1:**

## **THE COMMUNIST-ISLAMIST-GLOBALIST (CIG) CABAL PERCOLATED**

### **HOW THE CIG SET THE STAGE FOR PRESIDENT BARACK OBAMA**

After World War II, to make the United Nations work, globalists had to marginalize the United States so that this country could not become another Germany. They used racism to cripple the country. The segregation problems occurring in the South gave globalists the fodder they needed to attack the U.S. In 1962, the United Nations issued the UN Educational, Scientific and Cultural Organization (UNESCO) approving the Anti-Discrimination Convention.

To solve its racism issue, the United Nations told America that it had to prepare youngsters to be more loyal to the world than the United States. Teachers were encouraged to eliminate words, phrases, descriptions, pictures, maps, and classroom materials that caused pupils either to feel or to express love for the U.S. UNESCO pushed American officials into passing the Higher Education Act of 1965, which allowed foreign elements to creep into the American educational system.

To further the globalist agenda, in 1954 a Congressional committee found that corporate foundations were rewriting American history in school textbooks and colleges were quietly undermining American principles. Globalists – corporations, the media and academia – so violently disagreed with the preliminary findings, that the report was squashed and never released.

Near 1950, a leader of the Muslim Brotherhood came to this country and was shocked at what he saw: pro wrestling, dancing in public, etc. He returned home and vowed that the Brotherhood would “rid America of its miserable culture.” The group began the process through front organizations targeting American universities and ultimately communities. Traditionally the Muslim Brotherhood has a five-step process for taking over a country. It used to be based on the percentage of Muslim population in the country. As the population percentage grew, Islamist activity went from unremarkable to quite aggressive until the percentage reached 50 percent or more. Then the country would become a Muslim country.

Piggybacking on top of the globalists in 1989, the Brotherhood announced their 30-year plan to

take over America. Efforts over the past 40 years had fallen short of their goals and the plan, focusing on success from within U.S. institutions and leaders, had to be accelerated. Although the first Trump administration temporarily blocked their efforts, the Biden administration within Obama's backing and migrant invasion, enabled the Brotherhood to revive their plan with gusto. Consequently, in many places throughout the U.S. with just two to five percent of the population, Muslims are now moving through the Stage 3 of the takeover, instilling such things as no-go zones and Sharia law.

Since 1920 Communists have tried to take over the United States. In the 1950s they disclosed their plan to the sleepy American public that was published in the Congressional Record. They would conquer the country from within, infiltrating institutions from universities to government. To accelerate their progress, Islamists employed the same technique as the saddled up to globalist presidents the Bushes, Clinton and ultimately Obama.

When the Bushes welcomed China into the World Trade Organization and let that economy which had robbed our manufacturing ability over the years and steals our technology at a cool \$600 billion a year, the Asian giant greatly helped the communist cause in America by buying real estate and companies as Chinese citizens began to resettle here and attend American universities.

***These three groups came together in the 1960s in what now is the Communist-Islamist-Globalist Caba (CIF).***

In 1965, Democrat President Lyndon Johnson destroyed the African American family through a huge welfare program called the War on Poverty. A woman could get more money from Uncle Same than her employed husband, so fathers began to leave the family. Globalists triggered the women's movement to put a wedge between men and women and further split up the family unit. Congress passed the Higher Education bill that allowed foreign donors and actors into the U.S. education system. Today most of the foreign money comes from Qatar – the Islamist Muslim Brotherhood financial center – and China – the communist China Communist Party.

In the turbulent 1960s and 70s, Herbert Marcuse – a German communist – and Saul Alinsky – a communist atheist – both of whom Obama idolized became the New Left anti- establishment, opposed to all traditional American morals and values, and inculcated American universities.

In 1989 the globalist Bush presidents backed the Chinese Communist Party (CCP) after the Tiananmen Square massacre and American manufacturing flooded into that now Asian giant seeking cheap labor and materials to boost their profits. The Bushes then welcomed China into the World Trade Organization where the country began to dominate in trade with all WTO members and saw their economy rise for Gross Domestic Product of \$50 billion annually to over \$13 trillion, second largest economy in the world in less than two decades. Did this benefit the American worker? Of course not. As the wealth gap widened between the top 10 percent and bottom 90 percent, America a slept as their economy sank, China's blossomed and the American wealthy got richer.

Piggybacking on top of the globalists, the Muslim Brotherhood announced their 30-year plan to take over America and while the first Trump administration was a stumbling block to that plan, they restored it vigorously thanks to the Biden migrant invasion.

In 2006 the rising CCP began investing heavily in the United States buying up everything from farmland to movie theaters, sending Chinese students to American universities to steal U.S. intellectual property and placing Chinese nationalist strategically around the U.S.

# PART 2

## OBAMA’S FUNDAMENTAL CHANGE OF THE UNITED STATES

### DESROY AMERICAN CULTURE AND CAPITALISM

# CULTURE

All three factions of the CIG want the same thing: a different America with a totalitarian regime, an obedient public and an economy controlled by a government-big business alliance.

Barack Obama promised the CIG that he would do this through his campaign promise to fundamentally change America. To incorporate these three isms into his overall plan, the former president had to transform American *culture* and *capitalism*.

To undo American culture, Obama weaponized racism to ensure the United States morphed from a predominantly Western cultured white country into a multiracial non-country. He did this in a three-part process.

First, Obama had to attack Christian values, morality, and the family. He stoked racism to crush all three. He painted Western democratic society as a white privilege invention. White supremacists were the upper-dog, the oppressors, and minorities were the underdog, the oppressed. Who would not support the underdog? And if you didn’t you were a racist, a bigot, and, by extension, a conservative, even a Nazi. It was *bad* to be a Christian Nationalist.

To destroy Christian-Judeo American roots, he bad-mouthed Christianity and Judaism over 100 times during his administration and coated his Common Core K-12 curricula – developed by Pearson Education and funded by Qatar and Saudi Arabia – with Islam. (FN) He subtly coerced States to adopt his version of Common Core by threatening to withhold federal funds if his system was not adopted. This allowed not only Islam into grades K-12, but portrayed, especially through supplemental materials not properly reviewed, Muslims as oppressed and white Americans as oppressors.

With this context in place, he used Diversity, Equity and Inclusion (DEI) to dampen meritocracy and instill mediocrity in American life. He used Critical Race Theory (CRT) to make white people feel ashamed of their heritage while making minorities feel hopeless and victimized. This across-the-board indignation tore apart families that were focused on preserving

the classical American Dream. He then used transgenderism to lay the groundwork for transhumanism. By accepting the concept of transgenderism, the younger generation would be more receptive of more substantial change like cyborgs or human-machine combinations. Globalists hope that cyborgs with the proper indoctrination will be more pliable than rugged individuals.

Second, as a lawyer steeped in Constitutional law, Obama with his CIG proclivities knew how to both strengthen Constitutional law and weaken it. He elected to weaken it. He first attempted to cripple law enforcement. Again, employing racism, he showed how the police were the oppressors and minorities were oppressed victims. It did not matter that blacks make up 13 percent of the population and commit 53 percent of crimes. The former president only focused on how cops predominantly policed African Americans.

With the call to “defund the police,” came two dangerous precedents. One, journalists were permitted to publish whatever they wanted as long as malicious intent was not involved. The media stuck to the Obama narrative and anyone who didn’t was deplatformed or silenced just as Saul Alinsky instructed radicals to do to conservatives nearly 50 years ago. In fact, while such criticism was labeled “misinformation,” under Biden media literacy was created to teach people that what the government said was true and anything else was not.

Two, Constitutional law was quietly but deliberately ignored when it did not fit the Obama narrative – such as illegal phone taps, lying to Congress, and others that were committed with impunity.

Third, these two steps set up Obama’s third key principle – illegal immigration. Once Americans became “tolerant” of all minorities, the country was ready for mass migration which was already occurring in the CIG-controlled European Union. American culture and religion had been softened, and the rule of law had become selective. It was time to flood the country with minorities from around the world to de-white America, marginalize the society through DEI practices and make way for a more subservient society. This mixture provided fertile ground to the communist-Marxist contingent while wealthy globalists welcomed cheaper labor and more Democrat voters.

Everyone entering the country was a minority – oppressed and should have not just the backing but financial support of every red-blooded American despite the cost. Those who opposed this invasion were bad, racist...Nazis.

Consequently, the running narrative during the Biden years was that the migrant invasion was a myth and the borders were secure. That was a lie, but survived scrutiny because it favored the underdog. The media, the Deep State, academia, etc. claimed the borders were fine, no need to worry. Even Republican senators unsuccessfully tried to pass legislation to allow 5,000 migrants cross every day.

A year past Obama's 16-year reign, is his power still percolating? Absolutely. Despite electing Donald Trump to a second term, specifically to deport illegal aliens, the narrative still favors migrant retention, including violent criminals, while bashing those charged to deport – ICE.

The wind should be at the backs of President Trump and Tom Holman. Most Americans want illegal aliens out, along with paid communist-Islamist agitators. The most visible leaders of anti-ICE are corrupt Governor Waltz and Mayor Frey, both of whom are up to their eyeballs in a \$19 billion theft of the American people, based on the activities of the migrant Minneapolis Somalis.

Yet despite this scenario, the Trump administration is apparently standing down, withdrawing 700 ICE agents from Minneapolis as the News chants "ICE must go" 24/7.

Just like the George Floyd situation in Minneapolis, the current ICE crisis with the killing of two individuals who blocked lawful government action is an example of Obama's use of racism as a weapon. In January 2026, 130 people were killed in Chicago. No one knows the names of any of those people. But they do know the names of the two people killed in Minneapolis. Why? Because the CIG spotlights these two casualties are racist murders when the facts show that they were not. And while the CIG claims migrants contribute to American society, the fact is over 60 percent of illegal minorities are on the public dole thanks to hard-working U.S. citizen taxpayers. Plus migrants have a negative impact on U.S. schools, hospitals and American affordability since they occupy residential apartments and houses. Leftist judges are blocking the removal process every step of the way. ICE agents are being dragged into court while agitators can invade church services with impunity.

Why does the Left get away with this upside-down narrative. Because of the enduring power of Obama's racism gambit.

## PART 3

# CAPITALISM

Obama had a deliberate four-part plan to replace capitalism with socialism-backed corporatism.

### ***Expand the Wealth Gap***

A year after Obama took office, the top 10% of Americans owned 93% of wealth, leaving a mere 7% for everyone else.

The bottom half of Americans watched their wealth shrink by two-thirds while 95% of economic gains went to the top sliver of Americans. During COVID, the increase in billionaire wealth leapt by 70% as the Federal Reserve continued to use quantitative easing to boost the stock market, 90% percent of which the top 10% of Americans owned.

Capitalism operates on the premise of proceeds from profit is reinvested in the company to grow it, continue to innovate and increase productivity. With the number of hedge funds operating on Wall Street – presumably greater in number than MacDonald franchises – have caused a structural change in U.S. financial markets. Much of the wealth generation during the 16 Obama years came from non-productive trading to increase investor wealth rather than corporate reinvestment. This inversion was made possible by decreasing American manufacturing and productivity in favor of cheaper, more profitable production in China. As a result, the Obama years saw Gross Domestic Growth (GDP) of less than two percent annually while China's annual productivity thrived. Obama and the Fed had deliberately enriched oligarchs while sacrificing American industry and bolstering that of China.

Expanding the wealth gap was critical to Obama's plans mainly because it gave elite oligarchs a seat at the government table.

### ***Replace Republicans and Democrats with Nationalists and Globalists***

During Obama's first two terms, the Supreme Court allowed globalists to donate boundlessly to politicians, which heralded the sale of Congress members.



Throughout the Biden years, the Senate was 49% Republican and the House 51% Republican. Nevertheless, based on their voting records, Globalists consisted of 69% of the Senate and 65% of the House. Of the top 12 critical issues for Republican voters, including immigration, crime, the Ukraine War and others, over 70 percent of Republican representatives voted against their voters' wishes or did nothing to stop legislation to the contrary. No wonder Congress' approval rating in 2024 fluctuated between 13 – 16%.

Why this betrayal? Because they only need voters every two or six years. In between they work for big donors, over 13,000 registered lobbyists and 100,000 underground lobbyists. On average, in-state contributions to House members amount to 60% of their donations; out-of-state contributions 40%. In the Senate, on average, in-state contributions are 34%; out-of-state contributions 66%. Of the 533 Congressional members at the time, the mean amount of contributions from big donors was 93%, just 7% from small donors.

As a result, donors and lobbyists now control Congress: wine and dine the politicians and often write legislation for them.

## *Concentrate Industry*

Although small businesses are the backbone of capitalism, two of every three fail due to rising costs, over regulation and taxation, and decreasing access to capital. The Obama regime ensured that such penalties crippled small companies. Then he focused on bolstering the largest firms in five key sectors:

- **Banking:** While he bailed out the top 10 American banks, which catered to big business and virtually owned the Federal Reserve, Obama watched as 342 small banks – the financial lifeline of small businesses – failed between 2010 and 2014.
- **Healthcare and Food Production:** By having big business control the food supply with an increasing amount of processed food with minimal government regulation enforcement, both food producers and the medical industry have reaped windfall profits. The U.S. spends the most on health but has the sickest society in the developed world.
- **Big Tech:** Obama gave a green light to Silicon Valley firms to expand as they saw fit if they, along with the media, served as the purveyors of the Democrat narrative and monitors of misinformation against that narrative.
- **Military:** Obama purged the military and installed officers loyal to him. By supporting the military and by extension the Deep State intelligence apparatus, he fed the third biggest D.C. lobby group, the Military Industrial Complex.

By focusing on these five sectors, Obama strengthened the largest lobby groups in

Washington D.C. and implemented a government-big business partnership to control American society financially, socially, medically and food-wise. Meanwhile in 2015 Obama heavily backed the Green New Deal, claiming as he did with healthcare, that energy prices would drop. This alternative fuel policy, replete with government subsidies, drove prices skyward as wind and solar began to replace oil and gas. Expensive and inefficient green energy boosted inflation while rewarding China, the producer of alternative energy equipment.

Meanwhile because of events like the Ukraine War, the five top oil producers amassed over \$250 billion in profits between 2021 and 2023. But they used their profits to buy back stock to enrich themselves and shareholders.

This scenario prompted greater industry concentration. By 2017 three quarters of U.S. industries had experienced concentration with the top four firms in these industries gaining most of the control and market share.

The explosion of concentration is simply explained. Large corporations enjoy higher profit margins and economies of scale which limit competition. They thrive on positive abnormal stock returns and technological innovation where they corner the market on patents. Still industry concentration has benefited most from lax antitrust enforcement. In 2024 alone, mergers and acquisitions vaulted by 50% to \$4.5 trillion. Both sides profiting from such maneuvers made it easier for them to offer buyouts to small companies for far more than they were worth.

## ***Add Socialism to Corporatism through Increased Federal Spending***

To further help globalists, Obama and Biden ramped up illegal immigration to lower blue-collar wages and restrict the employment and wages of American workers. Fed Chairman Powell claimed that “too much pay for people is a problem causing inflation” and illegal migrants would prompt wage reduction. Yet studies disclosed that migrants cost the government \$400 billion annually, not to mention the disruption and expense that occurred in overcrowded schools and hospitals.

Further, H1 B visa holders, who work for a fraction of what Americans should receive, also crippled wage growth. Over the Obama-Biden regime, H1 B visas doubled from 200,000 in 2010 to 400,000 in 2024.

Consequently, American citizens were denied good jobs while uncontrollable inflation made living, much less home ownership, increasingly grim.

Annual federal spending rose from \$4 trillion pre-pandemic to five years of over \$6.5 trillion as Biden added 15 million federal jobs in his first three years. Debt reached \$36 trillion with annual interest payments nudging \$2 trillion. The cumulative inflation rate

during the Biden years was over 21% with significant price hikes in food (24%), gas (33%) and electricity (31%).

With the bottom 90% of Americans struggling to make ends meet, Congress and Biden promised to solve the problem with falsely labeled legislation like the Anti-inflation Act, both of which only drove prices higher because of increased government spending.

So, Obama's corporatism created a new problem: greater inflation and cheap imported labor called for more socialized government subsidies, such as the hotly debated extension of Obamacare subsidies. The Obama solution: guaranteed income, swelling inflation further, with a digital currency with which government would police consumer purchases and limit consumer spending.

Obama's capitalism replacement: big government, big business-government alliance, controlled masses, and a dethroned dollar – the perfect platform for human-replacing Artificial Intelligence and the dream of the Globalist-Islamist-Communist Cabal.

## ***Intended Consequences***

The ultimate consequence of this four-pronged approach was the collapse of the dollar. Both the CCP and globalists wanted the dollar to fall as the reserve currency for the world. Weakening of the dollar has allowed the third world, headed by China and Russia, to put forth an alternative to the U.S. dollar. Currently the dollar as the world's currency – meaning the world trades in dollars and thus needs them – enables the U.S. to ramp up debt indiscriminately because debt is in dollars and the Federal Reserve can just print more. But if, say, the Chinese yuan backed by gold and supported by half the nations of the world, were seen as an acceptable alternative, especially in trading oil which is the heartbeat of global production, the dollar would not be in demand, and its credibility would have shrunk. This would result in a massive surplus of dollars, not just leading to inflation but hyperinflation.

Why would Obama or any American politician want to do this? Because they are globalists, not nationalists and to have an America where people could come and go at will through fluid migration gives globalists ultimate world access. They believe a global government could control all current countries the way globalists intend.

The problem, which the CIG doesn't yet understand, is that while they may be partners now, each independently wants to rule the planet. Islam calls for submission of all infidels. Communism, led by the CCP, wants to be the world's sole hegemon. And globalists think one world government with a financial system they control would give them ubiquitous power.

Did Obama – or any of the CIG – consider who would rule under a nationless world? China? The United States? A coalition of Middle East nations or maybe just Iran?

Russia and China sharing the spoils? The United Nations doesn't really work.

So who would lead and how?
